"Artist" will set forth the terms and conditions of engagement and compensation for services as performing entertainers.

**5. General Contract Conditions (unless otherwise stated in the attached contract rider documents):**

- a. If, due to severe illness, accident or other causes legally known as Acts of God, Artist(s) are forced to cancel this agreement, neither party, nor any representative shall be liable for any payment.
- b. Should inclement weather render performance impossible, Artist(s) shall nevertheless be paid in full as provided herein.**
- c. Artist(s) is an independent contractor and is not an employee of the purchaser while rendering entertainment services. Artist(s) being independent contractors assumes all state and federal taxes directly related to compensation for this engagement.
- d. If engagement is cancelled by the purchaser, the deposit is non-refundable.
- e. Cancellation by the Purchaser within 90 days of the performance date will result in liability for the entire contract price.
- f. If any provisions hereof are determined to be void by court of competent jurisdiction, the remaining provisions hereof shall remain in full force.

**6. Special Contract Provisions:**

All rights attached hereto become a part of this agreement:

- a. Artist Dressing Rooms / Food / Drinks / Lodging (Please reference hospitality rider for more details)
  1. Purchaser shall provide a designated room at the performance location for the artist(s)
  2. Room shall be used exclusively by the artist(s) for costume changes and wardrobe / instrument case storage
  3. If necessary, this room shall have the ability to be locked by the artist(s) during performance sets.
  4. Purchaser shall provide complimentary food (snack or deli tray etc.) a minimum of Ninety (90) minutes prior to the performance.
  5. Purchaser shall provide complimentary beverages (soft drinks, water, etc.) for the duration of the performance
  6. Purchaser shall provide complimentary lodging accommodations for artist(s) and support staff.
  7. Lodging shall be a minimum of Three (3) single occupancy rooms and Four (4) double rooms for approximately Eight (8) artists and Two (02) support staff. Lodging shall be within Five (05) miles of the performance location.
- b. Technical Requirements (Please reference production and backline riders for more details)
  1. Sound and Lights provided by artist(s) / support staff or by purchaser/venue.
  2. Artist will arrive approximately 180 minutes prior to contract starting time.
    - a. Access to the staging area needs to be clear to allow time or equipment set-up, sound check, and change of attire.
    - b. A staging area of 24 feet wide x 16 feet deep is needed to accommodate equipment.
    - c. Grounded electrical outlets near the stage area are necessary for quality sound and lighting. Min. 3-20-amp or 1-50-amp circuit(s).
    - d. The artist will not be responsible to make-up time if access to the stage area is impeded, delaying set-up.
